MINUTES: Motion by Joe Mulrooney, second by Virginia Tinoco, to approve the minutes of the Feb 1, 2017 Board meeting, without objection, passed unanimously.

PRESIDENT'S REPORT: On Feb 2, Scott and Rick met with Commander Murray and Tracey Pirie to discuss proposed revisions to the Habit Forming Substances section of the Conduct & Ethics Policy in light of the passage of Prop. 64 and the legalization of recreational marijuana in California. On Feb 10, Scott attended the retirement event for Assistant Sheriff Stewart and presented his plaque and retirement bonus on behalf of VCDSA. On Feb 12-13, Scott and Tony met with PORAC President Mike Durant and Treasurer Marcelo Blanco to discuss issues affecting law enforcement, and also attended the PORAC Board of Directors meeting. On Feb 14, Scott and Rick provided VCDSA membership information to newly hired DAI Adam Delgado. On Feb 15, Scott and other members of the Shoot Committee attended the committee meeting prior to the Board meeting.

EXECUTIVE DIRECTOR'S REPORT: Since the last Board meeting, Rick assisted one member with an Internal Affairs interview. On Feb 8, Rick, Victor, Albert Miramontes and Ray Dominguez met with Rebecca Willhite and LaToyya Wilson-Rodriguez of Sheriff's HR to discuss improvements to the VCSO bilingual program. Proposed changes include extending the requalification period from 18 months to 3 years and eliminating the written exam for Level I and II bilingual certification. Rick and Kasey made edits to the new VCDSA website under construction by NEP and the site should be ready to go live shortly.

FINANCIAL REPORT: Without objection, the Board accepted the financial reports.

- Site Needs & Use: The rain delayed the roof caulking and elastomeric coating to be done by Doug's Painting.
- Bylaws/Elections: No new business.
- Negotiations: No new business.
- PORAC: The annual PORAC Training Symposium will be held Apr 4-5 in San Diego. Scott, Shawn, Virg, Erik and James will attend on behalf of VCDSA. On Feb 12-13, Scott and Tony met with PORAC President Mike Durant and Treasurer Marcelo Blanco, and attended the PORAC Board of Directors meeting. So far, three candidates have announced their intention to run for president of PORAC in Nov 2017. The PORAC Board declined a request to contribute more PAC funds to help satisfy the \$500,000 debt incurred by the "Yes on Prop. 66" committee. Among the federal bills PORAC is supporting: SB 318 will provide additional funding for COPS; SB 139 will fast-track DNA evidence; HR 115 (The "Thin Blue Line Act") expand statutory aggravating factors in death penalty determinations to include killing or attempted killing of a peace officer, firefighter or other first responder; HR 426 will renew the ability of law enforcement to utilize military surplus equipment. Among the federal bills PORAC is opposing: HR 158 would create enhanced civil penalties for traffic stops conducted by plain-clothes officers or by unmarked police units when those stops result in serious injury or death of a person; SB 87 would prohibit a "sanctuary city" from receiving Economic Development grants.
- Scholarship: The 2017 VCDSA Scholarship Applications were sent to members by email and in the Rap Sheet and the completed applications must be returned by March 31.
- **Dept/Association Shoot & BBQ:** The Shoot Committee met prior to the Board meeting and began formal preparation for the 2017 Shoot, scheduled for Sep 23. The committee will meet again prior to the Board meeting on Wednesday, Mar 15, at 3:30 p.m.
- Charity: No new business.

OLD BUSINESS: Kasey Sirody began working with Rick on Feb 10 and she has had introductory meetings with a number of VCSO, County and vendor representatives.

NEW BUSINESS: The Board met in Executive Session to discuss legal issues.
